Action Research Network of the Americas (ARNA) Conference 2017 & the first ever 'Global Assembly for Knowledge Democracy'



The fifth annual Action Research Network of the Americas (ARNA) Conference was held from June 12-16, 2017 in Cartagena, Columbia. This conference celebrated the 40th Anniversary of the First World Symposium on Participatory Action Research (PAR), held in 1977 and led by Professor Orlando Fals Borda. The UNESCO Co-Chairs, Dr Budd Hall & Dr Rajesh Tandon participated in the conference deliberations and contributed to the discussions on PAR, in

various capacities over the 5- day long conference. On June 16, 2017, the last day of ARNA 2017, the first Global Assembly for Knowledge Democracy was hosted at Cartagena, Colombia. The assembly witnessed participation from academics from around the world, including Professor Boaventura de Sousa Santos, Prof Normando Soares, Dr Mariela Garcia, Dr Mourik Bueno de Mesquita, and Prof Felix Cadena, the great popular Mexican educator, among many others.

**Formal signing of Knowledge for Change (K4C) Consortium Agreement, Veracruz, Mexico**





The Knowledge for Change (K4C) global consortium made its first formal appearance at an exclusive session on June 22, 2017 at the Talloires Network Leaders Conference 2017, in Veracruz, Mexico. The session, titled 'Knowledge for Change & Social Responsibility of Higher Education' was jointly hosted by University of Victoria, Canada, and the UNESCO Chair in CBR.

President Jamie Cassels from University of Victoria, chaired the session, while Dr Tandon facilitated the proceedings and deliberations. President Cassels & Dr Tandon also signed a Memorandum of Understanding (MoU), marking the official launch.

### **Development of Mentor Training Program**

The first stage in the development of the K4C Consortium is the Mentor Training Program (MTP). The MTP will provide 21 weeks of training to mentors who will be selected by the various training hubs in the Consortium. The course design is underway for a 21 week course that will have on-line, face to face and field experience components. The MTP course design is led by the UNESCO co-chairs with inputs from the 60 or so partners in the emerging Consortium. It is expected that the MTP will begin in early 2018.

### **New GCRF Centre for Sustainable, Healthy and Learning Cities and Neighbourhoods (CSHLC) at the University of Glasgow**

The University of Glasgow has been awarded a grant worth £7.1 million to set up a *Global Challenges Research Fund (GCRF) Centre for Sustainable, Healthy and Learning Cities and Neighbourhoods (CSHLC)*. The award is part of a £225m international research funding announced by UK's Higher Education Minister Jo Johnson. Altogether, 37 interdisciplinary projects will receive investment over the next four years from the Global Challenges Research Fund (GCRF) Research Councils UK Collective Fund. A number of PASCAL's collaborators including *CityNet* in Seoul, the *UNESCO Chair in Community Engaged Research and Social Responsibility* in Delhi/Victoria, and the UNESCO Institute for Lifelong Learning in Hamburg are members of its international advisory group.

### **Role of European Union (EU) in the implementation of Sustainable Development Goals (SDGs) in the Asia-Pacific**

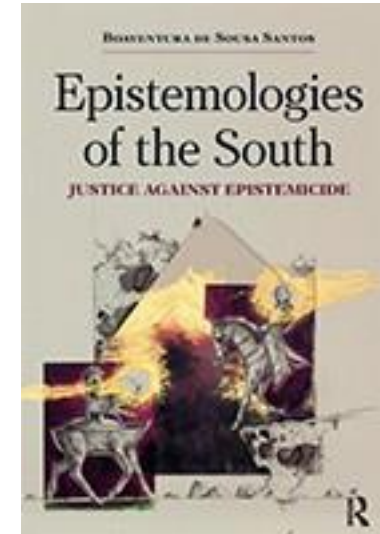

### **Epistemologies of the South: Justice against Epistemicide, by Professor Boaventura de Sousa Santos**

Initially produced in the year 2014, and authored by Professor Boaventura de Sousa Santos, this book explores the concept of 'cognitive injustice', and the failure to recognise the different ways of knowing by which people across the globe run their lives and provide meaning to their existence. Prof Santos shows why global social justice is not possible without global cognitive justice, as he argues that Western domination has profoundly marginalised knowledge and wisdom that had been in existence in the global South. ### **Everyday Exposure: Indigenous Mobilization and Environmental Justice in Canada's Chemical Valley, by Dr Sarah Marie Wiebe**

*Everyday Exposure* uncovers the systemic injustices faced on a daily basis in Aamjiwnaang First Nation. This book argues that social and political change requires an experiential and transformative "sensing policy" approach, one that takes the voices of Indigenous citizens seriously. The book has also been recently awarded the Charles Taylor Book Award, to be announced in San Francisco at the American Political Science Association annual conference this September.
